



## Participant's declaration of self-responsibility

The COVID-19 health crisis requires the adoption of measures to comply with the protocols set by the health authorities. The establishment and fulfillment of these measures requires a commitments and forms of action on the part, fundamentally, of the organization and its participants.

Reading and accepting this document is an essential condition to participate in the Ultrarunning Barcelona, organized by Corredors.cat.

As a participant in the Sports event, I declare:

- 1.- That I am aware of the measures that the organization will take in relation to my presence and participation in the competition, as a result of the health crisis caused by the spread of the COVID-19 disease.
- 2.- That I undertake to comply with the guidelines or follow the recommendations, as well as the instructions given by the sports authorities or personnel of the organization present at the competition in relation to the measures to avoid contagion by COVID-19.
- 3.- That I agree not to participate or take part in the event in case of suffering symptoms that may be compatible with the spread of COVID-19. (Likewise, cases in which the symptoms are suffered by third parties with whom the participant has or has had contact from which a contagion may arise.)
- 4.-That, in case of having knowledge of being affected by the COVID-19 virus, I undertake not to go, nor take part in the event (or with actions related to the race, fair, collection of numbers, etc.) to the extent that the health authorities do not state that my participation does not involve any risk, either for myself or for the other participants or assistants with whom I may have had contact.
- 5.- That I have knowledge, accept and assume that, in the current state and context, there is a risk of objective contagion of COVID-19 with the consequences that it may derive for my person in terms of health or problems that may even arise to cause death.
- 6.- That I accept that the event organizers adopt the measures indicated in the document (guide) that they have published in order to establish a reasonable security scenario for the event. In this sense, it is stated that people in charge of the event, in the course of the organization and execution of the race, can adopt measures or decisions that are necessary in relation to the establishment or application of the measures contained in the document (guide) published or any other that aims to provide proof of a safe environment in terms of avoiding COVID-19 infections.
- 7.- That, in the case of being infected by COVID-19, I exonerate the organizer of the event from any responsibility in relation to the possible damages that may arise from myself.
- 8.- That I accept that if it is necessary to adopt measures or decisions by the event organizer in order to preserve the health of people during the course of the competition, the essential obligations contracted by it cannot be considered incomplete, therefore that the payment of











amounts, compensation or refund of prices or amounts in the concept of registration or participation rights or costs incurred by me and / or my club cannot be demanded.

- 9.- That I accept that if I show conduct or behavior of non-observance or non-compliance with the orders and instructions of the organization's staff in relation to the security measures to avoid contagion by COVID-19, I may be subject to exclusion or disqualification of the event by decision of whoever acts as sports authority (referees or managers of the organization).
- 10.- That I accept that the sports measures set out in the previous section are understood without prejudice to other responsibilities that I could assume about other behaviors of non-observance or non-compliance with the orders and instructions that are applicable, and either in the sports-federative field, or in a different field.
- 11.- That in case of having knowledge or detecting a positive of COVID-19 of any participant on the day of the event, if so required by the health authorities, the information of their personal data will be made available to them, to proceed to carry out traceability with the people who may have had contact with the person affected by COVID-19.
- 12.- That in the case of being accompanied during the competition by the assistant that the organization authorizes to have, he/she assumes the same obligations as me as the registered runner.
